Take home messages

•Stakeholders aware of some resources, but don't always fit needs

•Barriers:

- Data
- Policymakers' capacity for action

•Enablers e.g.:

- Stakeholder involvement
- Local champions,
- appropriate tool design

•Leverage points:

- engage policymakers and stakeholders consistently
- Integrate research into existing processes
