

Meat Consumption Forecast

EU meat consumption (kg/capita)



EU total meat consumption is set to decline with 1,1% by 2030 ...

But poultry meat consumption is expected to up with 5,2%

We import a big amount of poultry meat

Imports to the EU per year ... average last 5 years





High EU Standards ... we have legislation!

Issue	EU	USA
General protection of poultry	Legislation on buildings, cleaning, system back-up and staff numbers	Not in legislation, the Animal Welfare Act excludes farm animals
Specific welfare requirements for broilers	Legislation on stocking rates; Litter quality; Lighting (pattern & intensity); Maximums for CO_2 and NH_3 in houses, if higher stocking rates are used	No legislation; Guidelines* state maximum stocking density and requirements for light and NH ₃
Maximum journey time during transport	Maximum journey time of 12 hours for poultry to slaughter (excluding loading and unloading)	'28 hour law'; No transport time limits in the NCC animal welfare program
Drivers and staff during transport	Legislative requirements for competence and authorisations for longer journeys	No requirement in legislation and not covered in NCC program

Non-EU countries have limited legislation on environmental protection, food safety and animal welfare.


Especially for animal welfare, research shows that the EU standards for broiler production are the highest in the world.
